In December of 2019, she became the Administrator for Interim Home Health and Hospice which currently serves

approximately 300 elders from Manhattan to Lawrence, KS. Joan continues her consulting business for state licensed homes as well as serving as the clinical consultant for KCAL. She enjoys sharing her gained knowledge and experience to help others grow in the senior care field.
