Certification Information

The Advantage Certified Wound Nurse (ACWN) Certification is valid for three years through the end of the month in which you received your certification. Registered Nurses and Licensed Nurses are eligible to sit for the exam. ACWN certification will be awarded to those who attend the course and successfully pass the examination with a score of 80% or greater. *Advantage Nursing Education is accredited as a provider of continuing nursing education by the American Nurses Credentialing Center's Commission on Accreditation. Dr. Robert Marriott is a general surgeon specializing in reconstructive surgery. He trained at New York Medical College, Saint Vincent's

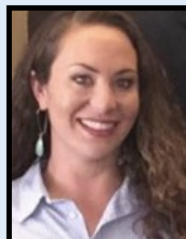

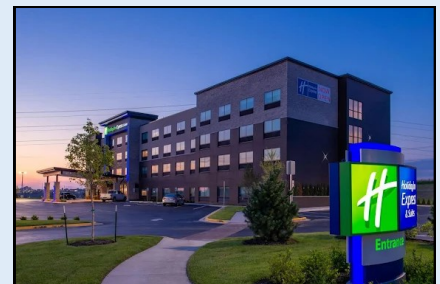
